5 6 7 8	1.	Bargaining unit employees will be provided training on duty time on new procedures associated with the implementation of the Clinic Cancellation of Patient Activities Memo for Hybrid Title 38 positions.

When a health care provider submits a request for planned leave, and if applicable a clinic cancellation of patient activities is required the employee will provide any designated forms to the proper Management and the leave request will be answered in accordance to the NFFE Master Contract on leave & related clinic cancellation guideline.
14 15 16	3.	Clinic Cancellation of Patient Activities for Hybrid Title 38 positions is intended to manage patient care and is applicable to both Scheduled Leave & Unscheduled Leave.
17 18 19 20	4.	If an employee is unable to perform their duties due to being incapacitated and requests immediate or emergency Sick Leave, the bargaining unit employee will not be required to complete a clinic cancellation form.
21 22 23 24 25	5.	FLMA shall be requested in accordance with the rule, law, and regulation. Bargaining unit employees will work collaboratively with their supervisor in determining if Clinic Cancellation is applicable. Management recognizes bargaining unit employees are not solely responsible for determining if clinic cancellation is required.
26 27 28 29 30	6.	In implementation of the Clinic Cancellation of Patient Activities Memo for Hybrid Title 38 positions the parties agree to follow Article 22, Leave, of the NFFE/ VA Master Agreement. The memo does not change Article 22 of the Agreement. Leave will not be arbitrarily denied.
31 32 33 34	7.	NFFE midterm team reserves the right to address issues related to the Clinic Cancellation of Patient Activities Memo for Hybrid Title 38 positions as they occur that have not been covered by this MOU or Master Agreement.
35 36 37 38	8.	Clinic Cancellation of Patient Activities Memo applies to Hybrid Title 38 Employees who have their own clinic with scheduled appointments for patient treatment and does not apply to Hybrid Title 38 Employees that are outside of these guidelines.
39 40 41 42	9.	NFFE Locals may elect to bargain on the local implementation of the Clinic Cancellation of Patient Activities Memo for Hybrid Title 38 positions at their facility and/or duty station. Bargaining may include substantive bargaining that does not conflict with the Master Agreement, MOU and nationally negotiated policy.
