

POSITION: Licensed Practical Nurse, GS-620-5/6**TYPE OF APPOINTMENT:** Temporary/ Permanent**NUMBER OF VACANCIES:** Multiple Full-time positions**FUNCTIONAL STATEMENT:** Licensed Practical Nurse**SALARY RANGE:** GS-5: \$26,699 to \$34,714; GS-6: \$29,761 to \$38,694 per annum**NOTE 1:** First consideration will be given to those who apply by 6/14/04**NOTE 2:** Applicants selected for permanent positions that have not been reviewed and approved by the professional nursing standards board will be given a temporary appointment not-to-exceed 13 months, pending board approval.**NOTE 3:** Applicants not selected for permanent positions will be given a temporary appointment not-to-exceed one year and one day, may be extended or terminated sooner, based on workload, staffing and budget.**NOTE 4:** Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.**NOTE 5:** This agency provides reasonable accommodations to applicants with disabilities. The decision on granting reasonable accommodation will be on a case-by-case basis.**NOTE 6:** Applicants without prior federal service will be appointed at step one of the grade.**NOTE 7:** Appointment to positions at this facility requires completion of a background investigation. The work conditions may require a change in the tour of duty, depending upon the needs of the Service.**LOCATION:** This position is located in the Bend Community Based Outpatient Clinic and is functional under the Primary Care Division, Portland, OR; however, it may be necessary to use the selectee's services at different locations throughout the medical center.**AREA OF CONSIDERATION:** Applicants will be considered in the following order: First consideration will be given to current employees of this Medical Center including Willamette National Cemetery, Regional Counsel and the Veteran Outreach Center. Second consideration: Any U.S. citizen.**Displaced/Surplus Federal Employees:** Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the **local commuting area** for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ICTAP eligibility with their application.**DUTIES:** The complete Functional Statement may be reviewed in Human Resources Management Division. The following duties and responsibilities are taken from the functional statement and are considered to be a brief extract. The incumbent, under the direction of the primary nurse, performs a variety of routine and complex patient care techniques based on the needs of the clinic to which assigned. Delivers skilled individualized patient care to adult and elderly patients within an ambulatory care setting. Duties include: observing patient needs and selecting priorities in patient care; anticipating the needs of the patient giving special attention to detail of care. Performs a range of monitoring activities that include taking and recording vital signs, obtaining specimens, glucose monitoring and setting up diagnostic examinations. Participates in patient/family health promotion education and activities. Administers oral, I.M., and S.Q. medications. Documents patient care in an accurate and timely manner using CPRS/VISTA/HPRO electronic entry. The incumbent will be expected to perform EKG, spirometry, cerumen removal, immunizations, dressing changes, straight cath, bladder scan, suctioning, and phlebotomy.**QUALIFICATIONS:**

- A. Must be a U.S. citizen.
- B. Full active, current and unrestricted licensure as a graduate licensed practical or vocational nurse in a state, territory, or commonwealth (i.e., Puerto Rico) of the United States, or District of Columbia.
- C. Graduate of a school of practical or vocational nursing approved by the appropriate State accrediting agency and/or the National League of Nursing at the time the program was completed by the applicant.
- D. Licensed practical or vocational nurses appointed to direct patient care positions must be proficient in (both) spoken and written English as required by 38 USC 7402(d), and 7407(d).
- E. For GS-5/6 positions one year experience at the next lower level is required.
