RESCISSION OF VA DIRECTIVE AND HANDBOOK 7241, TRANSPORATION AND MOTOR VEHICLES

- **1. PURPOSE:** This notice rescinds Department of Veterans Affairs (VA) Directive 7241, Transportation and Motor Vehicles (dated March 6, 1996) and VA Handbook 7241, Transportation and Motor Vehicles (dated March 6, 1996).
 - a. When issued in 1996, VA Directive 7241 and Handbook 7241 implemented and supplemented certain transportation-related procurement, audit, payment and documentation requirements set forth in part 101-41 of the Federal Property Management Regulation (FPMR) (41 Code of Federal Regulations (C.F.R.) part 101-41). Part 101-41 of the FPRM was subsequently rescinded in 2000 and relevant transportation-related requirements formerly located therein were revised and relocated in part 102-118 of the Federal Management Regulation (FMR) (41 C.F.R. part 102-118). 65 Fed. Reg. 24,568 (Apr. 26, 2000). Those requirements have been further revised since being moved from the FPMR to the FMR.
 - b. The contents of VA Directive 7241 and Handbook 7241 are now obsolete, based on the rescission of FPMR part 101-41 and subsequent changes to the relevant transportation-related procurement, audit, payment and documentation requirements currently set forth in FMR part 102-118 and in the General Services Administration documents that implement and supplement that part (such documents currently include the "U.S. Government Freight Transportation Handbook" and the "U.S. Government Passenger Transportation Handbook" that are incorporated by reference into various sections of FMR part 102-118) as well as subsequent changes to VA's organizational structure.
 - c. The Office of Acquisition, Logistics and Construction is currently developing revised versions of VA Directive 7240, Transportation and Traffic Management (dated May 24, 1996) and VA Handbook 7240, Transportation and Traffic Management (dated May 24, 1996) so that those policy documents appropriately implement and supplement the transportation management, procurement, audit, payment and documentation requirements set forth in parts 102-117 and 102-118 of the FMR.

3. RESCISSION: This Notice expires on year after publication. However, the rescission of VA Directive 7241 (dated March 6, 1996) and VA Handbook 7241 (dated March 6, 1996) will remain in effect permanently.
