FEDERAL RECOVERY COORDINATION PROGRAM

1. PURPOSE

a. This Directive establishes the Department of Veterans Affairs (VA) Federal Recovery Coordination Program (FRCP), a joint program of VA and the Department of Defense (DoD).

b. It also establishes requirements and responsibilities for managing and implementing the program in accordance with two Memoranda of Understanding between VA and DoD (dated August 31, 2007 and October 30, 2007).

2. POLICY. It is VA policy that the FRCP provides oversight and coordination of all clinical and non-clinical care identified in the Federal Individual Recovery Plan for eligible severely wounded, ill, or injured Servicemembers and Veterans.

3. **RESPONSIBILITIES**

a. The Secretary of Veterans Affairs will provide oversight for the program, to include adequate staffing and resources to develop and maintain the program and approval of strategic priorities for the program.

b. The Under Secretary for Health will ensure support for FRCP from Veterans Health Administration facilities and collaboration with relevant VHA programs and offices.

c. The Under Secretary for Benefits will ensure support for FRCP from Veterans Benefits Regional Offices and collaboration with relevant Veterans Benefits Administration programs and offices.

d. Assistant Secretaries will ensure support for FRCP through their organizational elements.
