Purchasing – Stock Issues

Patch Description

Introduction Patch RMPR*3*53 pertains to the **Stock Issues** option under the **Purchasing Menu**. After the installation of this patch, only items that are in the Prosthetics Inventory Program (PIP) will be allowed to be issued. Below are the **Stock Issue** options changed in this patch:

- **Issue From Stock** [RMPR ADD 2319] option
 - **Edit/Delete Issue from Stock** [RMPR EDT 2319] option.

Source Prompt deleted The *Source* prompt has been eliminated with this patch from both the **Issue from Stock** option and the **Edit/Delete Issue from Stock** option. This information (VA or Commercial) is automatically populated from the source of an item in inventory.

Other prompts reordered The following two prompts have been changed to appear in the following order with this patch:

- **Enter Pros Location**
- **PSAS HCPCS** (this is a mandatory field)

The purpose of changing the prompt order was to facilitate those who have multiple locations when selecting HCPCS and streamline the process for user efficiency purposes.

Before this patch, a HCPCS was selected first and then the location, and if the location changed for the same HCPCS, users would have to exit and begin the process over. This process now matches the process to add an item to inventory.

Edit/Delete Issue from Stock option Editing of the *Unit Cost* prompt will be allowed during the **Edit/Delete Issue from Stock** [RMPR EDT 2319] option.

Warning: The default value from inventory will be displayed and you can enter a different value, but if you do this, only the NPPD and the 2319 will be reflected with the new edited value. It will not change the Inventory Reports; and therefore your Inventory Reports will not match the NPPD.

Negative Balances

Negative inventory balance

If there is a negative or a zero balance of an item in inventory, this patch will not allow you to perform a Stock Issue. An item must be available in stock to perform an **Issue from Stock**.

Zero Balance Message

The following message displays if an item is at a zero balance and you try to perform a Stock Issue. Notice that the **Enter Pros Location** prompt returns when an item is not available in inventory. You can then search another location for an item or request a different item.

Issue From Stock Option

Introduction

To issue from stock, you must select the **Stock Issues** option from the **Purchasing Menu**. Only items that are in the Prosthetics Inventory Program (PIP) will be allowed to be issued. There must be enough quantity on hand of an item in PIP for it to be issued as well.

Steps To issue an item from stock, follow these steps:

Step	Action
1	At the Select Stock Issues Option prompt, type IS for the Issue From Stock option.
2	The Site prompt displays for you to select a site.
3	Select a Prosthetic patient, and when the Disability Codes display, if all is correct, press <Enter> .

Steps To enter an initial issue from stock, follow these steps:

Step	Action
1	At the <i>Type of Transaction</i> prompt, select one of the four types, and press <Enter.>
2	Enter information in the <i>Patient Category</i> and <i>Item</i> prompts.
3	The <i>Enter Pros Location</i> prompt and the <i>PSAS HCPCS</i> prompt are shown in their new order with this patch (Patch RMPR*3*53).
4	Enter a <i>CPT Modifier</i> , a <i>PSAS Item</i> , <i>Vendor</i> , <i>Qty</i> , <i>Serial Number</i> , <i>Lot Number</i> and <i>Remarks</i> .

Step	Action
1	At the Would you like to POST/EDIT/DELETE this entry: (P/E/D): P// prompt, press <Enter> to select the default entry of Post to post the item that was given to the patient and reduce it from the Inventory count.

2	The <i>Site</i> prompt displays for you to select a site.
3	Select a Prosthetic patient, and if all is correct, press <Enter> .
4	The Stock Issue displays.

Step	Action
1	At the <i>Type of Transaction</i> prompt, select one of the four types, and press <Enter.>
2	Enter a <i>Patient Category</i> and an <i>Item</i> . at the respective prompts.
3	The <i>Enter Pros Location</i> prompt and the PSAS HCPCS prompt are shown in their new order with this patch (Patch RMPR*3*53).
4	At the Would you like to Edit <i>CPT Modifier</i> Entry? N// prompt, type Y for Yes or press <Enter> for No.
5	At the <i>Enter PSAS Item</i> prompt, press <Enter> to accept the default or make a change.
6	At the <i>Select Vendor Name</i> prompt, press <Enter> to accept the default or make a change.
7	At the <i>Unit Cost</i> prompt, you can <u>now</u> change the default entry with this patch.
8	Change the <i>Qty</i> , <i>Delivery Date</i> and <i>Serial Nbr</i> prompts if necessary.
