1. Introduction

This document describes how to deploy and install the Blind Rehabilitation patch ANRV*5.1*11 web application, as well as how to back-out the product and rollback to a previous version or data set. This is a VistA "Informational" patch.

1.1.Purpose

The purpose of this plan is to provide a single, common document that describes how, when, where, and to whom the Blind Rehabilitation web application will be deployed and installed, as well as how it is to be backed out and rolled back, if necessary. The plan also identifies resources, communications plan, and rollout schedule. Specific instructions for installation, backout, and rollback are included in this document.

1.2.Dependencies

The Blind Rehabilitation web application requires that Identify and Access Management (IAM), Blind Single Sign-On Internal (SSOi) be provisioned for the application and that users of the application Link any of their existing VistA accounts with IAM's Link My Account.

ANRV*5.1*11 project is for installation on a fully patched Veterans Health Information Systems and Technology Architecture (VistA) system. ANRV*5.1*11 is a VistA "Informational" patch.

1.3.Constraints

The deployment, installation, back-out, and rollback roles and responsibilities are shown in Table 1.

3. Deployment

The deployment is planned as a standard VistA National Patch Module (NPM) patch rollout. Once approval has been given to nationally release, 'Informational' patch ANRV*5.1*11 will be released from the NPM.

ANRV*5.1*11 will be released as an 'Emergency' 'Informational' patch. There are no VistA software changes..

The deployment will take place on the BRS GUI/Web Server. Upon completion, the server version will be 5.1.5.5.

3.1.Timeline

The duration of deployment and installation is a two day emergency 'Informational' patch as mentioned above in the special note. There is no changes to VistA.
