
### Rocky Mountain Regional VA Medical Center Dental Clinic General Practice Residency Program

#### **Program Goals and Objectives**

- 1. At the completion of the program the resident will be able to provide multidisciplinary, comprehensive and emergency oral health care that is coordinated by them.
- 2. At the completion of the program the resident will be able to obtain informed consents on a variety of patients.
- 3. At the completion of the program the resident will be able to function effectively within interdisciplinary health care teams, including consultation and referral.
- 4. At the completion of the program the resident will be able to direct health promotion and disease prevention activities.
- 5. At the completion of the program the resident will be able to assess, diagnose and plan for the provision of multidisciplinary oral health care for a wide variety of patients including patients with special needs and medically compromised.
- 6. At the completion of the program the resident will be able to coordinate and manage the delivery of patient-focused oral health care.
- 7. At the completion of the program the resident will be able to provide advanced dental treatment modalities in the specialties of prosthodonites, endodontics, oral surgery, periodontics and implant dentistry.
- 8. At the completion of the program the resident will be able to provide <u>restorative</u> treatment of single teeth at a complexity that exceeds the level accomplished in pre-doctoral training.
- 9. At the completion of the program the resident will be able to restore/ replace teeth with <u>fixed</u> <u>prosthodontics</u> at a complexity that exceeds the level accomplished in pre-doctoral training.
- 10. At the completion of the program the resident will be able to replace teeth with <u>removable prosthodontics</u> at a complexity that exceeds the level accomplished in pre-doctoral training.
- 11. At the completion of the program the resident will be able to diagnose, treat and manage <u>periodontal disease</u> at a complexity that exceeds the level accomplished in pre-doctoral training.
- 12. At the completion of the program the resident will be able to provide <u>endodontic treatment</u> at a complexity that exceeds the level accomplished in pre-doctoral training.
- 13. At the completion of the program the resident will be able to perform <u>oral surgery treatment</u> at a complexity that exceeds the level accomplished in pre-doctoral training.
- 14. At the completion of the program the resident will be able to evaluate and treat <u>dental</u> <u>emergencies</u> at a level beyond that accomplished in pre-doctoral training.

- 15. At the completion of the program the resident will be able to provide pain and <u>anxiety control</u> <u>utilizing behavioral and pharmacological techniques</u> at a level beyond that accomplished in predoctoral training.
- 16. At the completion of the program the resident will be able to manage medical emergencies.
- 17. At the completion of the program the resident will be able to manage dental implants.
- 18. At the completion of the program the resident will be able to manage oral mucosal disease.
- 19. At the completion of the program the resident will be able to manage temporomandibular disorders and orofacial pain.
- 20. At the completion of the program the resident will be able to manage occlusal disorders.
- 21. At the completion of the program the resident will be able to perform thorough physical evaluation and medical assessment.
- 22. At the completion of the program the resident will have had training and experience that will ensure they are able to manage same-day surgery patients.
- 23. To provide training to prepare residents for practice management
- 24. At the completion of the program the resident will be able to critically review relevant scientific literature.



## Application

Application materials are due by **October 15**. A personal interview is required. Interviews are generally conducted in November and December.

In addition to the standard application materials, the following items are required:

- Small photograph
- Curriculum vitae
- Postdoctoral Dental Matching Program code number

## Denver Area

The Denver metropolitan area has a population of approximately three million people, ranking it as the 22 largest metro area in the U.S. Known as the Mile High City, Denver's suburbs reach into the foothills of the Rocky Mountains. ### Rocky Mountain Regional VA Medical Center

The Rocky Mountain Regional VA Medical Center (RMRVAMC) is dedicated to providing quality health care to veterans. The Dental Service offers a one-year hospital-based general practice residency (GPR) to four select dentists each year **starting July 1**.

The GPR focuses on comprehensive and emergency dental care for veterans with a wide variety of oral health needs.

Through clinical training and experience, residents enhance their skills in treating medically, physically, and mentally compromised patients.





# **Oral Surgery**

Three months of the resident year are devoted to oral surgery and emergency care (on-call duty). Surgery cases range from outpatient to hospital admissions. Residents gain operating room experience by treating patients in the OR, and by rotating on the Anesthesia Service for an additional two weeks.

Residents provide consultations to medical center physicians and regularly interact with other health care personnel.

A two-week rotation in Emergency Medicine exposes residents to urgent care and internal medicine. Thus, residents have ample opportunity to integrate their knowledge of dentistry and medicine in the hospital setting.

Duty hours are variable while on-call, in the OR, and on anesthesia rotation.

# **Didactic Program**

While the residency is primarily a clinical experience, didactic learning opportunities are included. Seminar, literature review, and treatment planning conferences continue throughout the year.

The attending staff is committed to lifelong learning and to improving the quality of dental care.





# **General Dentistry**

Residents practice general dentistry for eight months of the training year. Each resident is assigned an operatory fully equipped for fourhanded dentistry.

Dental laboratory services range from simple to advanced prosthetics, both removable and fixed. General dentists, as well as specialists, are available for consultation.

Specialties include periodontics, prosthodontics, endodontics and oral and maxillofacial surgery.

Regular dental clinic hours are 7:00-4:30, weekdays.

## Admissions Procedures

Admission to the Rocky Mountain Regional VA Medical Center GPR is highly competitive. Candidates must be citizens of the United States and must provide proof of expected graduation from an accredited North American dental school.

Appointment will be made without regard to ethnic origin, sex, or creed. Application is made through PASS (Postdoctoral Application Support Service of the American Association of Dental Schools):
