(b)(6) suggested I write to request a meeting with Secretary Wilke for the purpose of discussing a proposed partnership agreement between our organization, Challenge America, and the Zahel Disabled Veterans Organization (ZDVO) in Israel. ZDVO is the organization Secretary Wilke visited during his trip to Israel last fall. Following this trip, press coverage from his visit cited an interest in forging a relationship with ZDVO: "he and the VA look forward to working with Israel and ZDVO in the future." Given this interest, we humbly request a meeting with Secretary Wilke and his senior leadership team to discuss this exciting opportunity to forge a partnership agreement with ZDVO. It is our hope that this arrangement will speed up the pace of technology transfers between our countries, so that together we might accomplish dramatic improvements in the lives of injured veterans and their families.

Founded in 2009, Challenge America is a 501(c)3 national nonprofit that connects service members, veterans and their families to resources and solutions that build community and give purpose to their lives. To advance this mission, Challenge America operates three initiatives: Challenge America: Makers For Veterans (CAMVETS); The Military Sisterhood Initiative (MSI); and Music Therapy Retreats for Veterans with post-traumatic stress. On December 3, 2018, Challenge America signed a CRADA with VHA Innovation Ecosystem and VA Northeast Ohio Healthcare System for the purpose of maximize the impact of our CAMVETS program. Following this agreement, Challenge America has worked with Innovation Ecosystem and the VA Northeast Ohio Healthcare System to run two successful CAMVETS programs in Cleveland. While these programs primarily served injured Veterans from Northeast Ohio, they also included wounded IDF Veterans affiliated with ZDVO. To date this innovative program has produced fifteen working prototype solutions that dramatically improve the lives of injured Veterans and their families, with Provisional Patents filed on four of these (plans are in place to file additional Patent Applications in the coming months). Our primary points of contact with the VA, who include (b)(6) with Innovation Ecosystem and (b)(6) in the VA Technology Transfer Program, played key roles in advancing these efforts.

Challenge America initiated the relationship with ZDVO in 2017 as part of our strategic plan to speed up technology transfers between our two countries. Over time, these efforts were reciprocated, with agreements reached by both sides to coordinate the inclusion of wounded IDF Veterans in Challenge America programs and initiatives. It was during this process that AIPAC invited Challenge America to its 2019 Policy Conference, where we were honored from the Main Stage for our efforts to collaborate with Israeli organizations to improve the lives of injured US and IDF Veterans. As our relationship with ZDVO matured, we received an invitation from the ZDVO Director General, Avi Lehrman, to meet with ZDVO senior staff in late March, 2020, so that we might formalize a partnership agreement between our organizations.

It is our hope that we can arrange a meeting with Secretary Wilke and his leadership team prior to our scheduled meeting in Israel. Our preferred dates for this meeting are March 10-11 or March 17-18; however, we will certainly welcome other opportunities to meet, provided these dates do not conflict with any prior commitments.
