




Lack of Affordable Housing








Growing Affordability Gap

Shallow Subsidy Research

- The housing safety net does not currently meet the needs of the poorest families. It's a persistent and growing problem; millions pay more than half their income on rent (Mary Cunningham, Urban Institute, 2014)
- Families with high rent burdens spend significantly less on food, clothing, and healthcare than low-income families with affordable housing; they also experience higher levels of stress and depression.

- Of Veteran households with monthly incomes between \$0 and \$2,000, and who received shallow subsidies between October 2020 and March, 45 percent increased their income – double "traditional" SSVF services.

Flexibility with Shallow Subsidy

- Where there are ample HUD-VASH vouchers and other community resources, Shallow Subsidies may be better utilized as a homelessness prevention tool
 - Shallow Subsidy awards are not subject to 60/40 TFA limit
- For those worried about ongoing funding
 - All grantees are carrying substantial FY 22 awards into FY 23
 - There are currently large unspent balances in Shallow Subsidy awards
 - The President's Budget proposes increasing SSVF budget from \$420 million to \$731 million in FY 23, providing **annual** boost to funding (vs current 2 year Shallow Subsidy award)
 - The Shallow Subsidy service is cheaper than open-ended rental support under Stafford Act





Spending and Budgets









Current Spending Overview

- Awarded \$298,875,000 for National Shallow Subsidy (SS) Expansion
 - Project Period 9/1/21-9/30/23
- As of August 2022, grantees have drawn \$20,849,925 in Shallow Subsidy Expansion Funds
 - 7% drawn down and we are 44% through this 25-month budget cycle
- According to grantee HMIS uploads into the repository
 - From October 2021 through July 2022, there have only been 2,236
 Veteran households enrolled in SS Nationally






Current Spending Overview

- FY22/ARP Target Budget Dates
 - 07/01/2022-03/31/2023
- Awarded \$420 million for FY22
 - As of August 2022, grantees have drawn down \$9.3 million
- Awarded \$44.5 million in American Rescue Plan (ARP) funds specifically for Health Care Navigation and Legal Services
 - As of August 2022, grantees have drawn down \$158,209
















Budget Overview









Budget Overview

- Shallow Subsidy (SS) awards have a target end date of 9/30/23 and the Program Office has the authority to extend these awards for an additional year.
- FY renewal funding can be used for SS if needed
- The President's budget contains funding to sustain Shallow Subsidy service, so future funding is anticipated at a level to continue provision of this service beyond 9/30/23.







Shallow Subsidies







Shallow Subsidies Overview

• Is a service of SSVF and not a separate program

- Is a two-year commitment by the grantee to the household-unless the household terminates or receives a voucher or another source of permanent housing subsidy
- Can be augmented by local funds and other nonfederal resources, if available







Shallow Subsidies Overview

- Stable monthly rent subsidy set with maximum subsidy of 50% of the actual rent amount in the lease for the unit.
 - Rent must be reasonable for the unit size
 - Percentage set as determined locally by grantees with shared geography in the CoC
- Subsidy amount is fixed over the 24-month commitment
 - Differentiating it from Rapid Rehousing which can be adjusted to more or less of the contract rent based on client needs and varies in length of time
 - No recertification required after Shallow Subsidy service transition so no disincentive to increase income





Important Considerations

- Must be eligible for SSVF when transitioning to Shallow Subsidy service type
- Generally, requires minimal supportive services/tenancy supports
- Has the ability to pay the balance of the rent
- Only needs shallow rental assistance differentiating it from HUD-VASH services
- Veterans can be recertified at the end of the 24-month assistance period, if income eligible and still in need of subsidy support





The subsidy calculation is based on the actual rent amount of the unit. If a grantee has set the rate at 50% for their community rate and a Veteran is leasing a unit for \$1,000 per month, the monthly subsidy amount would be \$500, as long as the rent is reasonable for that unit size.







Targeting

Families who are severely rent burdened

 May be particularly important for those on fixed income

 Veteran population aging with higher rates of disability - more on social security, SSI







Prevention Screening

- Fall 2021 SSVF HP Screener provided broader flexibility for Stage 1
 enrollment
 - Veteran report of anticipated housing loss within 30 days
 - If discharge and income eligible, immediate enrollment into SSVF services and Rapid Resolution Efforts
- For Veterans in deep poverty or who meet other target groups, expedite SSVF enrollment to offer Shallow Subsidy services
 - Can use Homelessness Prevention Exceptional Circumstance
 Waiver to document Veteran TFA offerings when Veteran household
 does not meet Threshold Score standard for the community.
 - Grantees can adjust Threshold Score requirements for those Veterans who will be offered Shallow Subsidy services immediately in SSVF
- Keep capacity in mind for Veterans who need normal rental assistance prior to Shallow Subsidy service, particularly those with sudden loss of income or who cannot initially pay 50% of rent





Outreach and Engagement

- Renew efforts to outreach into communities/areas with high poverty and severe rent burdens, e.g., communities where historically disadvantaged groups live
- Veterans who were housed or have engaged with VA or other homeless programs in the past and may need further support to keep housing
- Communicate with partners about potential for Shallow Subsidy as an additional tool in the SSVF toolbox for severely rent burdened Veterans
 - PHAs receiving public housing applications
 - VA Medical Center teams including Veteran Hotline
 - Veteran Service Officers and State/County Veterans Programs
 - 211 and related hotlines and Coordinated Entry points
 - County and State Government who manage other rental assistance programs/funds







Summary

- Grantees have a lot of SSVF resources right now especially Shallow Subsidy funding
- Rents are rising and low-income Veteran households are at risk of homelessness
- Use Shallow Subsidy support as an extension of HP to stabilize Veterans in housing for longer periods
