



Since 2008 the Veterans Administration (VA) has been developing Medical Foster Home (MFH) programs for Veterans who are unable to live alone. There are currently 726 MFH across the United States.

## Quality and safety are paramount as outlined below.

- Caregivers are carefully selected.
- Frequent home visits are made.
- Education on care issues is provided to caregivers by VA staff.
- Policies are written to guide program development.
- Agreements are signed between MFH



#### **HOMES must:**

- be ownered iteres and Vateriand be the caregiamily and flestence

- be inspected by a multidisciplinary Home Based Primary team that includes a safety officer
- comply with all state and local licensure requirements and regulations, including construction, fire, maintenance, and sanitation
- meet applicable provisions of the most current fire protection Assoc. Life Safety Code.

#### **CAREGIVERS** must:

- complete an application and be interviewed by the MFH coordinator and other HBPC staff
- be financially stable and at least 21 years of age
- have formal or informal patient care experience
- be physically able to provide care with a written plan for a backup relief person and/or emergency situation
- agree to communicate with Veteran's health care team any significant changes in the Veteran's condition and have the ability to follow treatment plans.
- ensure a congenial and homelike atmosphere within the home.
