VA Boston Healthcare System Post-Baccalaureate Registered Nurse Residency Program

The VA Boston Healthcare System, the largest consolidated facility in VISN 1, encompasses 3 main campuses and 5 outpatient clinics within a 40-mile radius of the greater Boston area. The consolidated facility consists of the Jamaica Plain Campus, located in the heart of Boston's Longwood Medical Community; the West Roxbury Campus, located on the West Roxbury/Dedham line; and the Brockton Campus, located 20 miles south of Boston in the City of Brockton. In addition to the 3 main medical centers, the Community Based Outpatient Clinics (CBOCs) that make up the VA Boston Healthcare System (VA BHS) are located in Framingham, Lowell, Quincy, Plymouth and Causeway Street (Boston).

The VA Boston Healthcare System Post-Baccalaureate Registered Nurse Residency Program (PB-RNR) is a Commission on Collegiate Nursing Education (CCNE) accredited RN Residency program designed to provide additional training and support to Bachelor of Science in Nursing (BSN) graduates. Didactic and precepted clinical components provide a range of experiences in the application of nursing evidence-based clinical practice, and veteran-centric care.

The Post Baccalaureate Registered Nurse Residency Program is designed to bridge nursing academic education and professional nursing practice. As a successful graduate of the program, the participant will be an integral part of the interprofessional team and well positioned to initiate your life-long professional nursing career.

Program Structure

The VA Boston Post-Baccalaureate Registered Nurse Residency program is designed to provide the new graduate RN opportunities to effectively transition to competent professional nurses who provide safe, quality care, with a focus on:

- 1) Developing effective decision-making skills related to clinical judgment and performance
- 2) Incorporating evidence into practice
- 3) Developing clinical leadership skills at point of care
- 4) Practicing collaboratively as members of the interprofessional healthcare

5) Formulating an individual career plan that promotes a life-long commitment to professional learning.

Post Baccalaureate Nurse Resident (PB-RNR) Trainees

- Assigned a preceptor for 12 months with a shared assignment
- 1st three months on host unit & 4th month RN Residents are introduced to other clinical areas throughout VA Boston
- Monthly Didactic and Evidence-Based Practice Seminars
- Matched with a professional mentor
- Participate in comprehensive evidence-based practice program supported by VA Nurse Scientists with completion of an Evidence Based Practice Scholarly Project
- Findings are shared at the Annual VA Boston Nursing Service Evidence Based practice/Research Day
- Completion of required program surveys and evaluations for ongoing program improvement

PB-RNR Program Eligibility:

- Must be U.S. Citizen
- Graduated from a CCNE or NLNAC accredited program with a BSN or Direct Entry-MSN, between August 2021 and June 2022
- Proficient in written and spoken English
- Background & Security Investigation are required
- Pass pre-trainee physical examination and subject to random drug testing
- Obtain current, unrestricted RN license by August 1, 2022

Application Requirements:

- RESUME: no more than 2 pages
- COVER LETTER
- PERSONAL STATEMENT: 400 words “Why I Wish to be Selected for the VA Boston Healthcare System Post-Baccalaureate Registered Nurse Residency Program”
- THREE LETTERS OF RECOMMENDATIONS: TWO from school faculty (one must be a clinical faculty) and ONE from Nurse Manager/Assistant Nurse Manager of Unit of Senior Capstone Experience (or if you are employed as NA, PCA, SNT or VALOR– your current immediate Nurse supervisor). Place sealed envelope or e-mailed directly from School Faculty/Nurse Manager to Nurse Recruiter at: **BostonVANurse@va.gov**
- TRANSCRIPTS: Official from school, sealed envelope
- DD -214: submit if applicant is a Veteran

Application Deadlines for 2022-2023 class:

- Applications are accepted from **December 1, 2021- April 15, 2022**
 - The residency program start date is **August 2022**

- Salary and Benefits:
