Consulting Services to Provide a Public Interpretation Program for the San Francisco Veterans Affairs Medical Center (SFVAMC)

I. General

The San Francisco Veterans Affairs Medical Center (SFVAMC) facility is located on 29 acres of land in northwestern San Francisco, immediately north of the Outer Richmond District neighborhood. The facility is bordered on three sides by scenic parkland of the Golden Gate National Recreation Area (GGNRA), including the historic Fort Miley Military Reservation (FMMR) Historic District. The land associated with the SFVAMC historically was part of Fort Miley, which the U.S. Army acquired in the 1890s to aid in the shore defense of the Golden Gate channel into the San Francisco Bay. As Fort Miley fell into disuse, ownership of 29 acres at the core of the larger property was transferred to the Department of Veterans Affairs (VA) in the early 1930s. From 1933 to 1934, the VA constructed a hospital campus including approximately 18 buildings and structures, many designed in the Mayan Art Deco style. To date, the majority of these historic buildings remain intact, with varying degrees of alteration, and a grouping including 14 of these buildings and structures and their landscaping was listed in the National Register of Historic Places (NRHP) as a historic district in 2009. Surrounding SFVAMC, the remainder of the Fort Miley lands became managed by the National Park Service's Golden Gate National Recreation Area in the 1970s, and the historic resources of Fort Miley were listed in the NRHP as a Historic District in 1980.

Every day, citizens view and interact with the historic SFVAMC campus, but many do not understand the site's significant historical role in the military defense plans for San Francisco, in the development of a nationwide system to provide healthcare to veterans after World War I, or in the popularization of the Art Deco style of architecture for prominent institutional and commercial buildings across the nation in the 1930s. The SFVAMC is a visible landmark in northwest San Francisco; a fixture in the views from heavily-used public spaces like the Golden Gate Bridge, the Marin Headlands, Fort Miley, the Land's End trail, and the streets of the Outer Richmond District neighborhood. The aesthetic beauty and sense of history of the site also are valued by the many veterans who receive healthcare there – nearly 1,500 veterans daily and over 60,000 unique veterans annually. The healthcare providers and research staff employed at the site actively use and enjoy its aesthetic and historic amenities. For each of these constituencies—public citizens, veterans, and employees—providing a Public Interpretation Program (PIP) will enhance understanding and appreciation of the history of both the SFVAMC and Fort Miley, as well as the significance of the work of the VA as a whole.

II. Project Background

In order to plan and manage growth of its campus, SFVAMC first prepared a Long Range Development Plan (LRDP) in 2006. Through discussions with the community and other interested parties, the VA updated the LRDP in 2012 and again in 2014. The process of evaluating the impacts to cultural resources and other environmental resources is summarized in the *Environmental Impact Statement (EIS): San Francisco Veterans Affairs Medical Center (SFVAMC) Long Range Development Plan (LRDP)*. Through the consultation process, the VA determined that its mission necessitated some significant expansion projects, while acknowledging their potential to adversely affect the cultural resources. To mitigate the potential adverse effects proposed in the LRDP, the VA entered into a Programmatic Agreement (PA) in 2015 that required the development of a

Public Interpretation Program (PIP) Historic Landscape Study (HLS), as well as a number of additional work products. This solicitation is a result of that PA.

This contract to complete a PIP is part of the following internal VA timeline for implementation of the requirements of the PA:

- A. 2015: Finalize the PA regarding the LRDP for SFVAMC (completed)
- B. 2015: Complete a Work Plan defining services required as part of the preparation of the PIP
- C. 2016: Designate funding for the PIP
- D. 2018: Complete PIP

III. Purpose

The purpose of the PIP is to formulate and implement a high-quality ongoing public interpretation program within the SFVAMC campus and possibly on the adjacent FMMR Historic District lands. Although public interpretation is not the central mission of the VA, the VAMC understands that public interpretation enhances the experience of being at the Medical Center for all who reside, work, receive treatment and services, and visit there. The process of developing the interpretive materials should be collaborative, borrowing from the wealth of knowledge and skills available among the staff of the GGNRA, the staff of the San Francisco Recreation and Parks Department, the neighboring community, and the veterans themselves. Public forums—both in person and online—should provide an opportunity to share materials and to encourage interested parties to educate one another. The PIP should focus on development of interpretive materials that are targeted toward the interests of a varied array of audiences, and that are readily accessible to members of these groups. Target audiences for the PIP should include, at a minimum, the populations of resident and non-resident patients at the SFVAMC, their families, veterans organizations, visitors to Fort Miley and Land's End, and residents of the Outer Richmond District neighborhood.

The quality of the interpretive materials should reflect the high quality of the historic architecture of SFVAMC and should communicate the priority that the VA places upon preserving its legacy and communicating effectively with its public constituents. (The high professional standards expected of the respondent are detailed in the *Technical Requirements* section below.) The interpretive materials also should express the SFVAMC's commitment to economic efficiency – providing the most relevant information to the greatest number of constituents in the most economic manner possible.

V. Technical Requirements

- Authors and/or staff must include personnel who meet Secretary of the Interior's (SOI)
 Professional Qualification Standards in the areas of History and/or Architectural History;
- Authors and/or staff must have successfully completed a minimum of three projects of similar scope and scale within the past 10 years;
- All PIP work products must follow the guidance set forth in the 2007 NPS publication entitled Foundations of Interpretation: Curriculum Content Narrative (http://www.nps.gov/idp/interp/101/foundationscurriculum.pdf).

VI. Scope of Work

The authors shall develop a PIP according to the following scope of work:

A. Project Initiation, including the following meetings and preparatory work:

- 1. Review and analysis of each of the documents listed in the *Government Furnished Information* section of this solicitation, as well as all of the publications listed in the *Technical Requirements* section above
- Development of a project contact list and log of all project meetings and communications, to be maintained and updated throughout the duration of the project
- 3. Attendance at a kick-off meeting with the internal VA project team
- 4. Attendance at a meeting with representatives from the Golden Gate National Recreation Area
- 5. Attendance at a meeting for interested community organizations in order to summarize the project and publicize the upcoming roundtable (VI. A.6):
 - a. Veterans organizations, such as the American Legion, the Veterans of Foreign Wars (VFW), the Coming Home Project, the San Francisco Veterans Equity Center, the Service Women's Action Network (SWAN), Swords to Plowshares, and the Association for Service Disabled Veterans (ASDV)
 - b. County Veteran Service Officers
 - c. Planning Association for the Outer Richmond District neighborhood
 - d. Friends of Land's End
 - e. Coalition to Save Ocean Beach
 - f. Friends of Sutro Heights Park
 - g. People for a Golden Gate National Recreation Area
 - h. City of San Francisco Veteran Affairs Commission
- 6. Organization and facilitation of a public roundtable meeting to solicit input regarding planned interpretive materials, including the following:
 - a. Development of a flyer with information regarding the roundtable, to be posted throughout the campus and distributed to the community and other interested parties via mail and email.
 - b. Development of a questionnaire regarding priorities for interpretive themes, to be distributed at the roundtable.
- 7. Development of a system for sharing information such as historic photos, historic documents, and personal remembrances related to the history of SFVAMC/Fort Miley—both online and in hard copy—to be maintained by SFVAMC.
- B. Development of a PIP
 - 1. Draft PIP. The authors shall prepare a draft version that shall include the following content:
 - a. Statement of Purpose that summarizes the various audiences for the document and their different priorities for interpretation. This section should reference an appendix that chronicles the public meetings listed above.
 - b. Brief narrative summaries of selected interpretive themes that are relevant to SFVAMC. Themes should be assigned a priority level, based on input from interested parties and coordination with the SFVAMC staff. Although the themes are subject to change based on public input, a preliminary list of themes to be explored is included as Attachment 1.

- c. Summary of the different possible vehicles and methods that can be used to communicate the interpretive information to the SFVAMC staff, patients, visitors, and the general public. This discussion should include descriptions of the pros and cons of each vehicle (such as expense, accessibility, security concerns, and appeal to different audiences), and considerations regarding what kinds of discussions typically are best suited for each vehicle. A preliminary list of possible interpretive vehicles is included as Attachment 2 to this solicitation. The summaries should cite precedents for each type of vehicle and provide illustrations and/or internet links for examples.
- d. Specific recommendations regarding the vehicle that is best suited to each selected theme, including:
 - i. The approximate length of any textual elements (e.g., number of characters and/or pages)
 - ii. Bibliographical sources for information to be included
 - iii. Proposed graphics to be included
 - iv. Any relevant technical specifications (such as printing requirements web hosting requirement/limitations, or materials and finishes for physical displays)
- e. Bibliography
- f. Appendices
 - i. Chronicle of public meetings
 - ii. Illustrated previous examples of each potential type of interpretive vehicle
- C. Solicitation of Public Comments
 - 1. Preparation of materials in electronic (PDF) format for dissemination to the public or consulting/interested parties (as detailed in Section V. Deliverables below)
 - 2. Preparation of responses to comments from the public or consulting/interested parties, to be completed with SFVAMC staff
 - 3. Finalization of the PIP in response to comments
- D. Development of an Implementation Plan:
 - 1. Cost estimates for each recommendation
 - 2. Timeline for implementing recommendations
 - 3. Final recommendations for options to be implemented, including an estimated budget for recommendations
 - 4. Up to three (3) meetings with SFVAMC staff to make final decisions regarding the options to be implemented
- E. Implementation of the highest priority recommendations. Funding for implementation will be requested separately by SFVAMC, based upon recommendations in the Implementation Plan, as a subsequent phase to this project. Contingent upon funding, work to be completed under this phase possibly may include the following:
 - 1. Developing the full textual content for selected options
 - 2. Developing the full graphic layout for selected options
 - 3. Fabricating any physical interpretive materials, either in-house or through subcontractors

- 4. Installing any physical interpretive materials, either in-house or through subcontractors
- 5. Launching any online materials that will be hosted by the SFVAMC
- 6. Arranging for hosting of external online materials, for a minimum of five (5) years
