
# Wilkes-Barre VA Medical Center PGY-1 Pharmacy Residency Program Program Code: 129513





#### **Facility Overview**

The Wilkes-Barre VA Medical Center serves approximately 37,000 veterans yearly. This VA is a medical and surgical facility with 68 inpatient beds and 70 nursing home beds.

### **Residency Program Overview**

Our ASHP-accredited program provides residents with a strong foundation to build their clinical skills. Residents rotate through a variety of clinical settings including internal medicine, ambulatory care, mental health, pain management, long-term care, and practice management. Our preceptors practice at the top of their license, under a scope of practice, allowing residents to learn and develop the confidence of a mid-level provider. Our program focuses on the well-being of our residents and does not require staffing on nights, weekends, or holidays to help promote a well-balanced work life.

Program Purpose: PGY1 residency programs build upon Doctor of Pharmacy (PharmD) education and outcomes to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives. Residents who successfully complete PGY1 residency programs will be skilled in diverse patient care, practice management, leadership, and education, and be prepared to provide patient care, seek board certification in pharmacotherapy (i.e., BCPS), and pursue advanced education and training opportunities including postgraduate year two (PGY2) residencies.
