Post-Baccalaureate RN Residency Program

Applicant Criteria:

• Be a licensed RN prior to program start

• Be a licensed RN for less than one-year post graduation from your nursing program and have **no** RN position work experience

<u>AND</u>

- Graduate of BSN or MSN entry level program, accredited by Commission on Collegiate Nursing Education (CCNE) or Accreditation Commission for Education in Nursing (ACEN)
- Submission of required application packet
- Minimum cumulative GPA of 3.0 from your nursing program
- Be a U.S. Citizen and meet standards for on-boarding, described below
- Commit to completing the 1-year RN residency program

Application Packet Requirements:

- 1) **Resume** (include clinical experience from nursing program, education, previous work experience, etc.)
- 2) Cover Letter (1-2 pages), including:
 - a. Why you want this opportunity
 - b. Why you desire to work with the Veteran population
 - c. Your top 2 clinical tracks of interest (see below), briefly describing your interest (and experience) in each
 - d. Discuss Clinical Tracks of Interest (subject to change):
 - 1) Ambulatory/Primary Care Patient Aligned Care Team (PACT) in outpatient primary care setting
 - 2) **Critical Care-** Critical Care, complex high acuity patient care
 - 3) **Emergency Department-** Emergency Department, accurate triage and implementation of algorithms
 - 4) Inpatient Medicine Unit (includes telemetry) medical inpatient unit
 - 5) Inpatient Surgical Unit (includes telemetry) post-op inpatient surgical unit
 - 6) **Mental Health** acute inpatient mental health unit, Residential Treatment Program and various outpatient mental health programs
 - 7) Oncology Care inpatient hospice unit and inpatient oncology medical unit
 - 8) **Operating Room** Operating Room, circulating and scrubbing
 - 9) **Outpatient Surgical or Medical Unit –** preoperative and pre-procedural care as well as postoperative/procedural care





- 3) **Professional letters of reference** (minimum of two letters of recommendation)
 - a. At least two from faculty members, speaking to your academic and clinical performance
 - b. Additionally, may include reference from a supervisor/leader who can speak to your work performance
- 4) Copy of Unofficial Transcript*
 - a. If pending confirmation of degree, an unofficial transcript can be submitted initially
- 5) Enrollment Verification*
 - a. Letter from your school verifying enrollment and tentative graduation date.

IF Selected there will be these Additional Requirements:

- 6) **Copy of Official Transcript** (show date degree conferred and cumulative GPA of 3.0)
- 7) Copy of RN license or NCLEX authorization letter with plan or testing appointment
- 8) **Onboarding requirements**** will be requested after initial review of qualifications, these include:
 - a. Proof of TB screening
 - b. Hep B vaccination or waiver
 - c. Proof of current flu vaccination

- d. Proof of health exam, health satisfactory to perform duties of training program
- e. Proof of Covid-19 vaccination, if completed
