

# VA Finger Lakes Healthcare System Postgraduate Pharmacy Residency

The Postgraduate Year One (PGY1) residency is a 52-week program designed to develop the resident's skills and competency in providing patient-centered care as part of an interdisciplinary team with a focus on primary care, mental health, and geriatrics. The program builds on Doctor of Pharmacy education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients with a wide range of conditions. By the end of your residency you will be eligible for board certification and postgraduate year two (PGY2) pharmacy residency training.

## Residency Program Learning Experiences:

#### Required Core Rotations (4-6 week blocks based on the rotation):

Orientation and Pharmacy Administration/Leadership ★ Pharmacy Operations: Inpatient, Outpatient and Quality Management ★ Anticoagulation ★ Primary Care ★ Geriatrics/Community Living Center ★ Mental Health

#### **Required Longitudinal Rotations:**

Quality Improvement/Quality Assurance Project ★ Academic Detailing with Teaching and Learning Certificate ★ Home Based Primary Care (panel management) ★ Staffing

#### **Elective Opportunities:**

3 electives, 4 weeks each (may extend to 6 weeks if desired)

## **Application Process:**

#### **Qualification Requirements:**

United States Citizen ★ Graduate of an ACPE-accredited school of pharmacy ★ Ability to obtain pharmacist licensure within 120 days of the start of the residency ★ Registered in the ASHP Resident Matching Program

#### **Apply through PhORCAS:**

Letter of intent ★ Curriculum vitae ★ Academic transcripts ★ Three letters of recommendation using the PhORCAS Standardized Reference Form ★ At least one letter should come from a preceptor with whom the applicant had a clinical rotation

An interview is required.
