Fellows must have completed all degree requirements for a Ph.D. or Psy.D. in Clinical or Counseling Psychology from an APA-, CPA-, or PCSAS-accredited program. 2. Fellows must have completed an APA- or CPA-accredited internship. 	
Describe any other required minimum criteria used to screen applicants:	
<ol style="list-style-type: none"> 1. Be a citizen of the United States. The Department of Veterans Affairs is unable to consider applications from anyone who is not currently a U.S. Citizen. Verification of citizenship is required following selection. All interns must complete a Certification of Citizenship in the United States prior to the beginning of VA training. 2. Federal law requires that most males living in the US between the ages of 18 and 26 register with the Selective Service System. Male, for this purpose, is any individual assigned male on their birth certificate regardless of current gender. Males required to register, but who failed to do so by their 26th birthday, are barred from any position in any Executive Agency. Visit https://www.sss.gov to register, print proof of registration or apply for a Status Information Letter. 3. Postdoctoral fellows are subject to fingerprinting and background checks following match selection. Match results and selection decisions are contingent on passing these screens.
