

Malcom Randall VA Medical Center Geriatric Physical Therapy Residency



About the Program

The Geriatric Physical Therapy Residency Program at the Malcom Randall VA Medical Center in beautiful Gainesville, FL, was founded in 2017 and is accredited by the American Board of Physical Therapy Residency and Fellowship Education. The residency is a one year training program designed to maximize clinical exposure and rigorously challenge the resident to higher clinical and academic achievement under the mentorship of specialist clinicians.

Mission

The mission of the Malcom Randall VA Medical Center's Geriatric Physical Therapy Residency is to honor Veterans by providing exceptional geriatric care to promote health and independence. The Geriatric Physical Therapy Residency includes exposure to multiple settings and specialty populations/issues within the geriatric umbrella. Practical experience combined with didactic training develops exceptional clinicians who will excel in the examination, evaluation, diagnosis, prognosis, and intervention for geriatric patients. The purpose of this geriatric physical therapy residency is to produce clinicians who demonstrate superior clinical skills and possess advanced knowledge regarding the identification and management of aging and related issues. The program emphasizes a learning approach that is patient-centered and evidence based.

Curriculum and Training

Over the course of the 12-month geriatric residency, residents will participate in clinical training modules reviewing and managing the body and system specific dysfunction throughout all available physical therapy settings. The curriculum of study and practice-based methodology will be based on available literature from the APTA, Geriatric Academy, and Medbridge. This includes selected publications that meet the requirements found in the Description of Specialty Practice (DSP), Description of Residency Practice (DRP), and Geriatric Certification Candidate Guide and covers contemporary literature in geriatric health, medicine, and rehabilitation.

In addition to the faculty of specialist PTs, residents will also consult with a multi-disciplinary group of core faculty from geriatric medicine, pharmacy, psychiatry/psychology, and social work. Throughout, residents will be evaluated for mastery in each of the following clinical areas: acute care (visceral, cardiac, pulmonary, delirium, orthopedics, psychiatry, neurology), outpatient (orthopedics, vestibular, specialty seating/positioning/wheelchair, amputee/brace clinic, frailty), sub-acute rehab, and homebased primary care for home safety evaluations. Each section will cover the differential diagnosis of pathology, identification of red flag symptoms, signs, lab values, the need for referral, imaging, and evidence-based modality and procedural interventions as they pertain to the area of care and need of the individual patient.

Program Highlights

- Residents have averaged >200 hours of 1:1 clinical mentorship (ABPTRFE requirement=150 hours)
- Residents receive salary and benefits with federal government as a 'Post Doctoral Fellow,' including pay and observance for all federal holidays
- Residents are granted 13 days of Annual Leave and 13 days of Sick Leave
- All course materials are furnished and purchased for residents under their name
- Residents are allowed to work within cutting edge areas of physical therapy care (Frailty, ED, Primary Care)
- Receive Experience and learning across multiple settings and domains throughout NFSG Veteran's Health System.

Accreditation

The Malcom Randall VA Medical Center Geriatric Residency is accredited by the American Board of Physical Therapy Residency and Fellowship Education (ABPTRFE).

Board Certification

The Geriatric Residency Program will prepare physical therapists with the knowledge and skills required to sit for and successfully pass the American Board of Physical Therapy Specialists (ABPTS)

board certification exam in Geriatrics. In addition to this, the program will prepare graduates to work as specialists within the VA and federal system.

- Successful completion of a CAPTE accredited Doctor of Physical Therapy Program
- Intended (or current) Physical Therapy Licensure in a state, territory or commonwealth of the United States
- US Citizenship
- Desire to attain an advanced skillset and specialty knowledge
