The VA Maine Mental Health Nurse Practitioner Residency (MH NPR) Program will provide an enriched educational experience for new graduates by offering didactic and clinical learning experiences. The program will inspire exploration of the best evidence to provide a holistic approach care of veterans in an environment of inquiry, excellence and openness, utilizing all healthcare disciplines to enhance the education of the mental health nurse practitioner.



Goals

Residents will spend time seeing patients during various clinical rotations at the Togus Campus with individualized progression of patient panels. Travel to the Portland and Lewiston outpatient mental health clinics may be required.
