# Individual Offices, Facilities, & Organizations

- VA's primary goal is to provide services to the 27 million
   Veterans who have served their country.
- This is done by the acquisition of products and services through various:
  - (1) Hospitals
  - (2) Clinics
  - (3) Veterans Integrated Service Networks (VISNs)
  - (4) Data Processing Centers
  - (5) National Cemeteries





### **Veterans Affairs Central Office**

- The Executive Director, Office of Procurement, Acquisition and Logistics (OPAL) oversees operations of the Central Office staff and OPAL field contracting offices at the NAC, SAC and TAC:
  - (1) The National Acquisition Center, Hines, IL (NAC) & Denver Logistics Center, Denver, CO(DLC)
  - (2) The Strategic Acquisition Center (SAC) & Strategic Acquisition Center-Frederick (SAC-F)
  - (3) The Technology Acquisition Center, Eatontown, NJ (TAC)
  - & Technology Acquisition Center, Austin, TX (TAC-Austin)



### The National Acquisition Center (NAC) Hines, IL

- Responsible for supporting health care requirements of the VA and other government agencies.
- Under the Federal Supply Schedule (FSS) and National Contract Programs, the NAC awards high volume multiple award schedule, national contracts and blanket purchase agreements (BPAs) for the delivery of:
- (a) Pharmaceuticals
- (b) Medical, surgical, dental, and patient mobility equipment/supplies
- (c) High technology medical equipment and much more . . . .

The NAC has over 2000 contracts and annual sales over \$16 billion. You can reach the NAC at nac@va.gov



## **Denver Logistics Center (DLC)**

- The DLC is also part of operations assigned to the NAC.
- The DLC provides holistic chain management for the VA National Hearing Aid and Home Telehealth Programs.
- Commodities managed include:
- (1) Hearing aids and accessories
- (2) Cochlear implants
- (3) Assistive devices
- (4) Batteries
- (5) Prosthetic socks and more . . . . .

#### **Technology Acquisition Center (TAC)**

#### Eatontown, NJ and Austin, TX

- Responsible for providing streamlined business and contracting solutions for a variety of major Information Technology programs.
- Also provides customers with innovative acquisition guidance in support of their complex IT procurement needs by utilizing strategically-sourced enterprise contract vehicles such as Transformation Twenty-One Total Technology Next Generation Contract, better known as (T4NG).
