# 1. Introduction

The SHRPE product makes enhancements to the Admission/Discharge/Transfer (ADT) /Registration (DG) application (patch DG\*5.3\*1034) to implement reports that would help Registration and Integrated Billing application users identify Former Service Members whose Primary Eligibility changed from EXPANDED MH CARE NON-ENROLLEE to a new Primary Eligibility with a verified eligibility status. These patients are no longer treated under the Other Than Honorable (OTH) authority (Veterans Health Administration (VHA) Directive 1601A.02). Additionally, implements a report that would help identify veterans that are registered for Presumptive Psychosis benefits. The report list the patient's episodes of care and released prescriptions to assist billing.

## 1.1. Purpose

These release notes cover the changes to implement reports that would help ADT/Registration (DG) application made by DG\*5.3\*1034 to identify patients that were treated under OTH authority and Presumptive Psychosis (PP) benefits. This is to provide details about eligibility changes and Department of Veterans Affairs (VA) care provided to these patients.

## 1.2. Audience

This document targets users and administrators of the ADT/Registration (DG) and Integrated Billing application and applies to the changes made between this release and any previous release of this software.

# 2. This Release

The following sections provide a summary of the new features and functions added, enhancements and modifications to the existing software, and any known issues for DG\*5.3\*1034.

## 2.1. New Features and Functions Added

The following are the features and functions added by DG\*5.3\*1034:

- Created a new option Presumptive Psychosis Reconciliation Report [DG PRESUMP. PSYCH. RECON RPT] to generate a list of patients registered under Presumptive Psychosis authority who have had episodes of care within the user specified date range.

## 2.2. Enhancements and Modifications to Existing

The following are the enhancements and modifications by DG\*5.3\*1034:

- Modified the Former OTH Patient Detail Report [DG OTH FSM DETAIL REPORT] to add sorting functionality . This allows users to have flexibility on how the report will be sorted.
