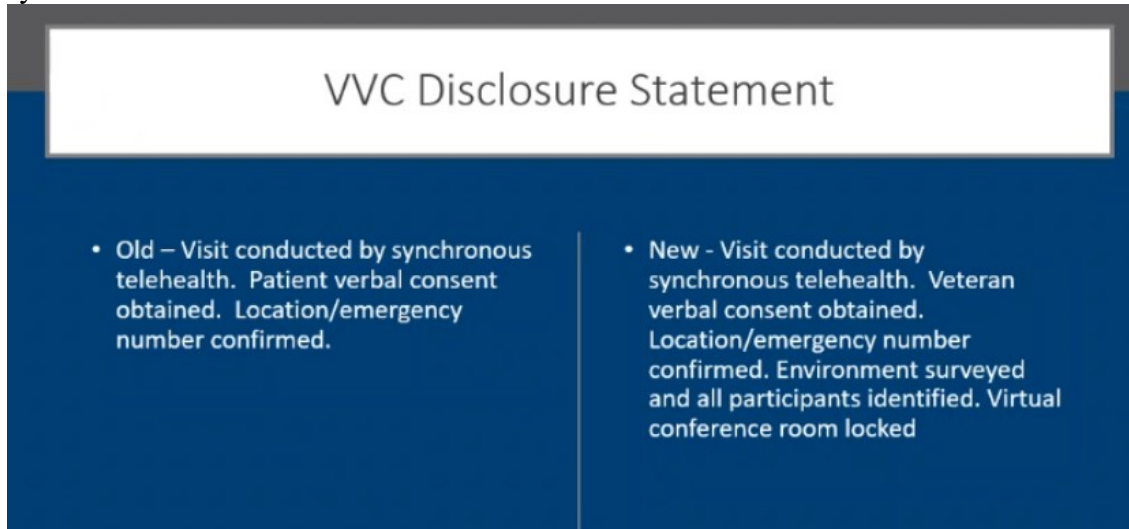

Description:

Guidance from the telehealth program office was recently released updating the required synchronous telehealth disclosure statement:



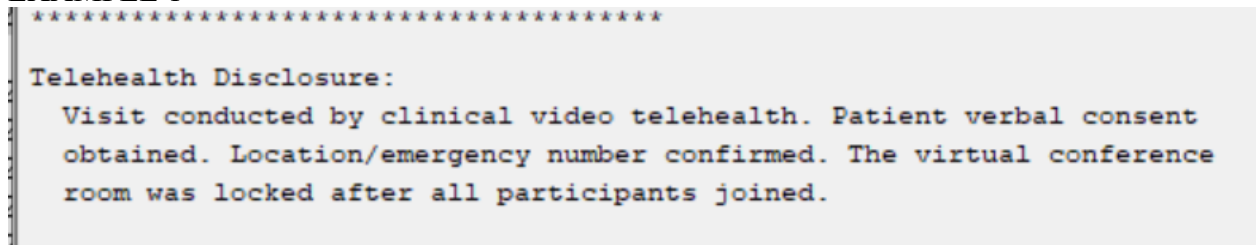

You should have installed Update 249 VA-STRENGTH AT HOME TEMPLATES and UPDATE 226 VA-VVC BLOOD PRESSURE TEMPLATE UPDATE prior to installing this update.

Using the menu Reminder Dialog Management, Reminder Dialogs, change your view to Element, search for and save the inquiry for the following reminder dialog elements. You will need to update these in the post install.

This update can be loaded with users on the system. Installation will take less than 5 minutes. This update is being distributed as a web host file.

 You will see several prompts, for all new entries you will choose **I to Install**
*For components that already exists but the packed component is different, you will choose **S to SKIP**.*

You will be prompted to install the reminder dialog component – You will choose to install all even though some components may have an X to indicate that they exist.
