Introduction

In October 2020 the Caregiver Support Program (CSP) implemented approximately 20 new notes/reminder dialogs in support of implementing changes to the Program of Comprehensive Assistance for Family Caregivers Program that were required under the MISSION Act.

This update includes edits to six (6) of the CSP dialogs to meet updated regulations outlined in phase two of the CSP expansion; documented in the MISSION Act. The link below highlights each edit made to the individual six CSP dialogs.
