# Introduction

---

## **VA-SPINAL CORD INJURIES AND DISORDERS Introduction:**

The [VSSC SCI/D Registry](#) was created to support the SCI/D System of Care in identifying and tracking Veterans with SCI/D who are eligible for SCI/D System of Care Services per VHA Directive 1176. The SCI/D System of Care mission is to support, promote, and maintain the health, independence, quality of life, and productivity of individuals with SCI/D throughout their lives. The [VSSC SCI/D Registry](#) is the informatics infrastructure which ensures quality and allows SCI/D national and local leaders to monitor areas of service delivery, which are identified as high-risk, high-volume, or problem-prone. The VA-Spinal Cord Injuries and Disorders template items are an extension of the [VSSC SCI/D Registry](#) in that it allows clinicians, administrators and leaders to further refine searches for certain patients. For example, patients with a high level of complete injury and who are actively using a ventilator, would be considered very high acuity regarding inpatient status. The template information will be integrated into the [VSSC SCI/D Registry](#) and reports products such that more refined information can support operations and ultimately excellent service to Veterans. This is the first time most of these SCI/D items have been automated. This template is mandatory for use at sites who are SCI/D centers. ## **VA-COVID-19 SCI/D SCREEN Introduction:**

The Coronavirus Disease 2019 (COVID-19) SCI/D Screen template is the national CPRS template developed for use at the [SCI/D System of Care Hubs and Spokes](#). Specifically, this template is to be completed by individuals as designated by appropriate facility officials for telephone, telehealth, or in-person screenings of individual Veterans included on the [VHA VSSC Spinal Cord Injuries and Disorders \(SCI/D\) Registry](#) to determine whether the Veteran has been diagnosed with or tested for COVID-19 (including verification of information in the COVID-19 Status Indicator Banner, as applicable), to identify potential health care and social needs, and learn about current use and interest in virtual care. For this population, this template is to be used in place of the national COVID-19 Screen template; relevant information and questions from the national COVID-19 screen template have been integrated into the COVID-19 SCI/D Screen template. If previously completed for a Veteran, the COVID-19 SCI Screen Template imports information from the Veteran's completed SCI/D Status Update template in relation to diagnosis, living setting, and caregiver status. Responses to the COVID-19 SCI/D Screen Template will be imported to the previously completed CPRS SCI/D Status Update template if there are changes in response. If a Veteran included on the [VHA VSSC Spinal Cord Injuries and Disorders \(SCI/D\) Registry](#) is screened more than once for COVID-19, the COVID-19 SCI Screen template may be used for all instances of screening. 



#### 5. Associate the reminder dialogs with the note titles in CPRS
