Introduction

The National Caregiver Support Program requested recent changes to the Veteran Initial In-Home Assessment, Interim In-Home Assessment, 90 day Caregiver Assessment and Annual In-Home Assessment templates for the Veteran as part of the program's response to VHA Privacy Office and VHA Health Information Management System (HIMS) privacy concerns. Privacy and HIMS require that these assessments separate out specific caregiver information sections from the original template and have those sections placed in the caregiver's collateral record. To meet this requirement the original assessments have been divided into two templates, one specific to the Veteran and one specific to the caregiver. The National Caregiver Support Program Office has taken steps to develop and implement two separate templates to replace the original templates to meet privacy requirements.

For the four in-home assessment templates being updated, below is a screenshot of how the template will look both before and after this update.




