Introduction

The Caregiver Support Program requested the recent changes to the Veteran Eligibility CPRS template as part of the program's response to the OIG report of August 2018. In that report, the OIG charged the VA with ensuring that all Caregiver Support Coordinators were properly applying the eligibility criteria of the program as outlined in Directive 1152. The National Caregiver Support Program Office has taken steps to develop and implement a standardized training to ensure this requirement is being met. In the process of developing the National training program, a review of the Veteran's Eligibility Assessment CPRS template, that is used to document the program criteria, took place to ensure that the template was consistent with the training. The review of the template found that while all the key elements were included in the template, the template did not utilize the same wording or the same order. For this reason, a request was made to modify the first half (only) of the existing CPRS eligibility template as this half is specifically related to the 7 primary eligibility requirements. The request was to ensure that PL 111-163, 38 CFR rules & regulations and the Directive 1152 as well as the CPRS template were all consistent.

The wording and order of the first reminder dialog group containing 7 questions is being updated to align with the wording and order of the questions in the policy.

Clinical Eligibility Criteria for Family Caregiver Program

***** MUST MEET ALL SEVEN PRIMARY CRITERIA *****

1. Did the Veteran or Servicemember (undergoing medical discharge) incur or aggravate a serious injury including traumatic brain injury, psychological trauma or other mental disorder, in the line of duty, on or after September 11, 2001?

2. Due to the serious injury(ies) sustained by the Veteran or Servicemember, is another person (Caregiver) required to assist with the management of personal care functions required in everyday living due to one or more of the following?

- Inability to perform an Activity of Daily Living
- Need for supervision or protection

- A 100% service connected disability for a serious injury incurred on or after September 11, 2001 for which the Veteran receives a special monthly compensation including an aid and attendance allowance

- The Veteran is service connected for a serious injury that was incurred or aggravated in the line of duty in the active military, naval, or air service on or after September 11, 2001, and has been rated 100 percent disabled for that serious injury, and has been awarded special monthly compensation that includes an aid and attendance allowance

- Significantly enhance the eligible Veteran's ability to live safely in a home setting
- Support the Veteran's potential progress in rehabilitation, if such potential exists
- Create an environment that supports the health and well-being of the Veteran
